

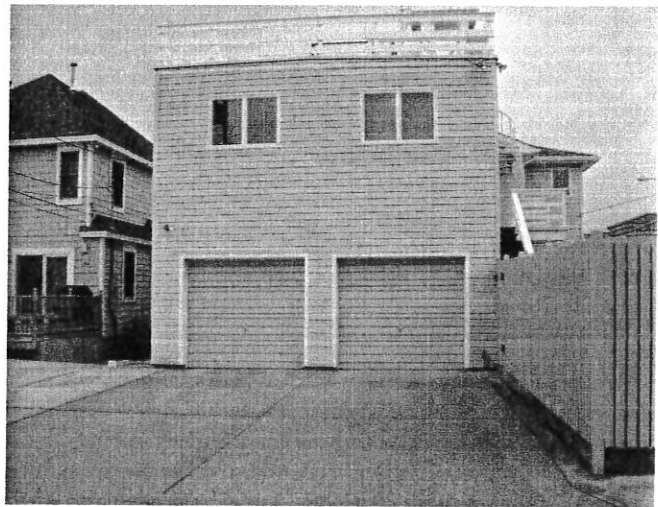

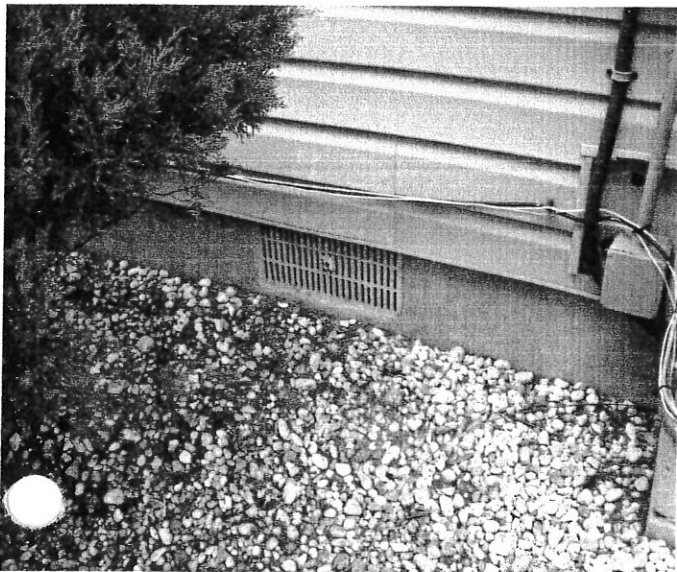
Front View
