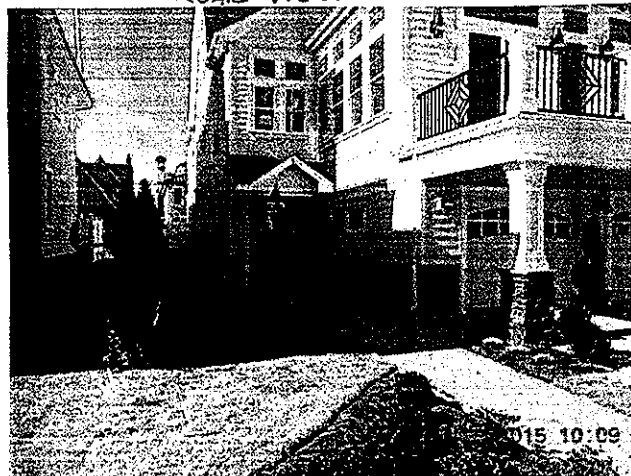

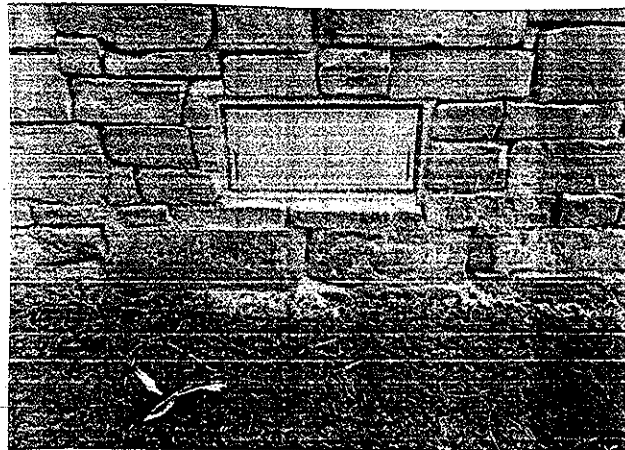

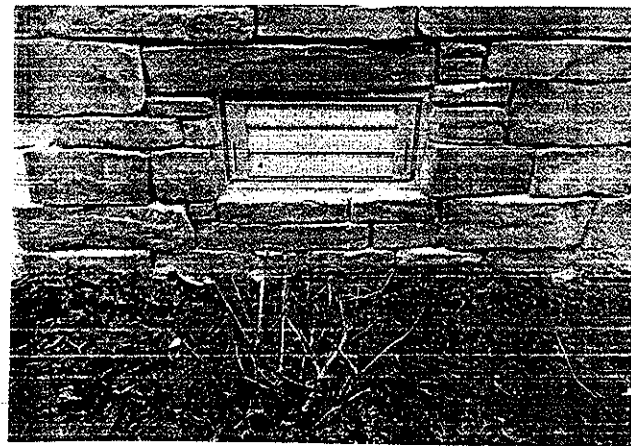

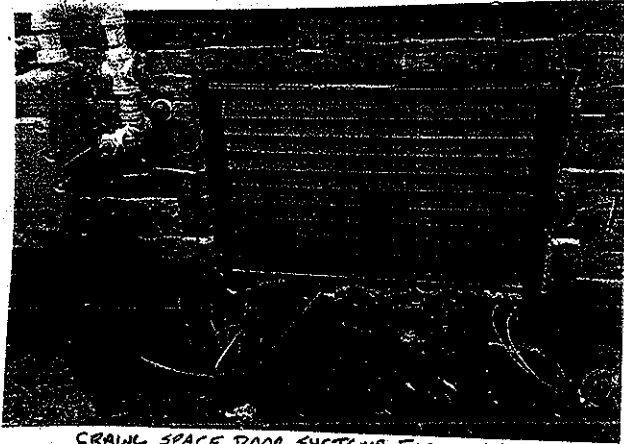
SMART VENT - MODEL 1540-510
