

**BOROUGH OF LONGPORT
ORDINANCE 2016-13
AN ORDINANCE AMENDING CHAPTER 110
LAND MAINTENANCE
OF THE CODE OF THE BOROUGH OF LONGPORT
ATLANTIC COUNTY, NEW JERSEY**

BE IT ORDAINED BY THE COMMISSIONERS OF THE BOROUGH OF LONGPORT that:

SECTION I: Subchapter 110-2 Enforcement of the Code of the Borough of Longport is changed to read as follows:

110-2 Notice

The Superintendent of Public Works or the Construction Code Official, or such official's designee, are hereby designated as the officers authorized to give notice, in writing, either personally or by mail, to the owner of lands as provided by this article, and the Superintendent of Public Works shall give such notice whenever directed to do so by the Commissioner of Public Works whenever said Commissioner shall deem it necessary and expedient to do so as provided by the provisions of this article. The notice shall inform the owner of the violation and direct that the same be removed within 10 days following the date of mailing or deliver of the notice, as the case may be.

SECTION II: All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgement shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION III: This Ordinance shall take effect immediately upon passage and publication as required by Law.


