**AN ORDINANCE AMENDING ORDINANCE 2018-03
SALARY, WAGES AND COMPENSATION IN YEAR 2018**

**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE
BOROUGH OF LONGPORT that:**

Section 1: The within described salaries, wages and compensation paid to the following officials, officers and employees shall be computed from January 1, 2018 and are amended as follows:

BEACH PATROL

Beach Patrol Captain (maximum of 85 days-boathouse days not included)
\$160.00 to \$215.00*

*Includes CPR and First Aid Stipend of \$3.00 per day. Officers of the Beach Patrol including Chief and Captain will not receive the Labor Day and EMT Bonus.

DEPARTMENT OF REVENUE AND FINANCE

Chief Financial Officer \$50,000 to \$80,000

Section 2: All ordinances, or parts of ordinances, inconsistent herewith are hereby amended as reflected herein.







Description: This Ordinance Amends the Salaries of Beach Patrol Captains and the Chief Municipal Finance Officer

ORDINANCE 2018-11
An Ordinance Amending Subchapter 147-19 Public Utilities pertaining to underground electrical installations of Chapter 147 - Streets and Sidewalks of the Code of the Borough of Longport, Atlantic County, New Jersey
Description: This Ordinance requires all underground electrical services within the paved cartway of any Street to be installed in open trenches to permit inspection by the Municipal Code SubCode Official. No trench shall be backfilled until inspected and approved.
