Open Public Meeting Announcement

MAYOR RUSSO - Fire Exits- Public Speaking time limit.

Approval of minutes for the 5/20/15 commission meeting. Mayor Russo made a motion to accept the minutes. Commissioner Leeds seconded the motion. ALL IN FAVOR – ALL AYES - none opposed.

Second Reading and Public Hearing on **O2015-04** an **Ordinance Granting Renewed Consent** and **Permission to SJ Gas to Use the Public Streets to Furnish Gas for Light, Heat and Power in Longport.** The public hearing was opened on this ordinance – no one wished to speak.
