Steven Greco and Krystle Torres Pallone received the **Honorable Service Award** for their dedication in staying in communication with and providing informational support and assistance to the officers on the scene of the shooting. Officer Christopher Ricciotti received the **Meritorious Service Award** for his actions of securing the interior perimeter of the Ventnor home under fire on October 3, 2016. Retired Officer Scott Hanson received the **Combat Cross Award** for his acts in neutralizing the active shooter and providing leadership under fire.

He recommended reaching out to neighboring towns to see how they are addressing their beach access permit.

PUBLIC COMMENT

Sabrina Blankenship of 1204 Atlantic Avenue noted that at the previous workshop there was discussion on parking boats in the borough and she wanted clarification as to what was specifically being addressed. Mayor Russo explained that the discussion was about boats parked in driveways and how this might affect off-street parking in the borough. Commissioner Lawler also added that there was also discussion about boats being parked in the street. It was noted that the ordinance regarding boats and parking needed to be reviewed.
