# BOROUGH OF LONGPORT WORKSHOP COMMISSION MEETING MUNICIPAL BUILDING, 2305 ATLANTIC AVE LONGPORT, NJ 08403 WEDNESDAY, August 19, 2020 – 4:00 PM

The meeting was called to order.

Municipal Clerk Kyle read the Opening Statement pursuant to the Open Public Meetings Act. A notice of this meeting was emailed to the Press of Atlantic City and the Current on August 14, 2020. In addition, copies of notices were posted on the bulletin board and filed in the office of the municipal clerk. Notices on the bulletin board have remained continuously posted.

Borough Solicitor Affanato, Administrator Porter, Engineer Carter, CFO Kelly, Police Chief Culmone, Zoning Officer Funk, and Municipal Clerk Kyle also present.

The Mayor stated the location of emergency exits.

### Mayor Russo:

Mayor Russo stated that he would provide his report at the regular Commission Meeting. He said that he would provide an update on the Wounded Warrior Program. He was also looking forward to updates on projects from the Borough Engineer and Municipal Administrator.

### Commissioner Leeds:

Commissioner Leeds discussed a large amount of mud and silt in the street associated with a construction site near Pacific and Yarmouth avenues. He noted that the street black top has been stained with cement and that street drains are being clogged due to the debris. There was discussion on the role the building department has in enforcing Code regulations regarding construction sites. Administrator Porter said that he would work on addressing this issue. Engineer Carter also noted that the Cape Atlantic Soil Conservation District could be contacted to help with enforcement. Commissioner Leeds expressed his concern that this is a very serious issue that needs to be addressed.

### Commissioner Lawler:

Commissioner Lawler discussed Resolution 2020-103 regarding an emergency repair at the 33<sup>rd</sup> Avenue bayside bulkhead. Engineer Carter explained that the bulkhead caved in and had been repaired. Engineer Carter noted that the resolution helped expedite the process for the repair. Commissioner Lawler also asked about repairing the sidewalk in the area.

Mayor Russo discussed drainage problems in the Borough. He also noted that he has concerns with landscapers not hauling away yard waste and that some continue to use leaf blowers with waste going into the storm drains. He discussed having a meeting with local landscapers at the end of the summer to

discuss these concerns. He felt that this might be a bigger issue in the Borough. He spoke to Zoning Officer Funk about a list of landscapers.

#### Municipal Administrator:

Administrator Porter discussed Ordinance 2020-06 that was introduced at the previous meeting and would have had a second reading today, but due to the Governing Body's concern with the ordinance, he worked with the Borough Solicitor to draft a new ordinance, O2020-07, that was more consistent with what the Governing Body was interested in doing. This new ordinance would take the place of O2020-06 and was on the agenda for the Governing Body's consideration at the regular meeting. Administrator Porter asked Police Chief Culmone to attend the meeting in the event there were any questions regarding the ordinance. Chief Culmone discussed the ordinance and provided an overview of how the need for an amendment came about. The Governing Body agreed that the sight triangle in the area needed to be addressed for safety concerns. Engineer Carter discussed sight triangles and how the Borough and other communities have addressed parking in shore communities. He explained that in general, providing parking was a driving force. The Governing Body noted that they would like to have input from the residents that would be directly impacted from the removal of the three parking spaces on Ventnor Avenue, but that it would be introduced for a first reading/ introduction. Chief Culmone also noted that a "No Parking" sign had been placed in the area by the County for nearly a month with no issues.

Administrator Porter said that work would soon be underway in Commission Chambers including the installation of new flooring and new chairs. He hoped that the flooring would be ready by the next meeting. He explained that resolutions were on the upcoming agenda for this work. He added that chairs for the dais still needed to be ordered.

Administrator Porter also discussed the proposed sidewalk project that would pave certain areas in the Borough that currently have grass instead of paved sidewalks. He said the estimated cost is \$187,000 and wanted to know if the Governing Body wished to address the project as a whole or if it should be addressed in stages. Engineer Carter also discussed the possibility of completing the project in two phases. He discussed doing in-fill areas first. There was discussion on how certain areas would be addressed regarding where the sidewalk would be installed, including areas that have a full sidewalk already on one side of the street. There was also discussion on using previously issued bond money for the Atlantic Avenue Point project to fund the sidewalk project. Administrator Porter also mentioned an outreach project that the Chief of Police is working that included crosswalks. He noted that this would be discussed in detail at a later time.

Administrator Porter explained that he has not received an update from the NJ Department of Environmental Protection regarding either the Municipal Public Access Plan, the Beach Maintenance Plan or the Fish and Wildlife aspect of the Beach Maintenance Plan for the last two months. Solicitor Affanato discussed ongoing furloughs at the State.

### Solicitor:

Solicitor Affanato had nothing further to report.

### Engineer Carter:

Engineer Carter said he provided a design of the well building. He added that costs are increasing due to code issues beyond the Borough's control. He discussed certain ramping changes including elevation requirements (13 feet) and changing of the ramp's slope. He provided an overview of the construction

process and noted that he is getting ready to go out for bid on this project. He said the well would be built first and then the building. Mayor Russo asked if the permitting was completed. Engineer Carter noted that he expected a sign off in the near future. He also noted that he anticipated that the project would completed sometime next year. Commissioner Lawler also discussed the water tower and said that it needs to be painted. Engineer Carter noted that the Administrator was working on this issue. Administrator Porter said that it was something that would be addressed in the spring. Engineer Carter explained that he wanted to have everything in order before he left at the end of the year.

CRS Update on the Atlantic Cape Coalition – "Multi-Jurisdictional Program for Public Information": Zoning Officer and CRS coordinator Funk provided an annual update on the Community Rating System and the public information program. He discussed on-going public information campaigns including providing information to help inform residents of flood hazards, flood insurance, where to get copies of elevation certificates, how to protect themselves and their property, as well as how to sign up for assistance if they have special needs. He discussed how this had been historically done through the newsletter and via safety bags, but that has ended. He also discussed information available on the Borough website. He also noted that he created a booklet, an Emergency Preparedness Guide, containing much of the discussed information and that is scheduled to be provided to residents soon. He also reviewed the history of the Atlantic Cape Coalition, the Flood Hazard Mitigation Committee and the program's success in the Borough. He also discussed the various stakeholders involved in the program. He noted that some of the goals included informing residents of flood risks, what is available information-wise and what tools the Borough has available to help residents. He also noted that the current proposed plan could change the Borough's CRS rating from a Class 5 to a Class 3, equaling an approximate 35% reduction in flood insurance premiums. He discussed the need for a regional public outreach message.

Mayor Russo discussed the number of members in the coalition and how it grew from three members to an estimated 13 members. Engineer Carter recommended adopting the plans if it could be obtained without having to further elevate homes above current regulations. Zoning Officer Funk noted that he believed the benefits could be achieved without further requiring an additional elevation of homes. He also discussed a past nuisance flooding evaluation study with Stockton University that has been beneficial to the Borough. Commissioner Leeds asked if a public meeting could be held to help provide this information to residents. Zoning Officer Funk noted that there is a virtual community meeting scheduled for later on that day from 6 to 8 pm for anyone who is interested. Commissioner Leeds noted that he would like to, at some point, host an 'open house' for the public on this information.

#### Municipal Clerk:

Municipal Clerk Kyle noted that the 'Key to the City' had been ordered for the Wounded Warrior.

#### Miscellaneous: No further reports.

#### PUBLIC COMMENT
