BOROUGH OF LONGPORT WORKSHOP COMMISSION MEETING MUNICIPAL BUILDING, 2305 ATLANTIC AVE LONGPORT, NJ 08403 WEDNESDAY, May 18, 2022 – 4:00 PM

The meeting was called to order at 4:00 pm.

Municipal Clerk Kyle read the Opening Statement pursuant to the Open Public Meetings Act. A notice of this meeting was emailed to the Press of Atlantic City and The Current on May 13, 2022. In addition, copies of notices were posted on the bulletin board and filed in the office of the municipal clerk. Notices on the bulletin board have remained continuously posted.

Borough Solicitor Affanato, Administrator Porter, Engineer Dennis, Police Chief Culmone, Fire Chief Clayton, and Municipal Clerk Kyle also present.

Mayor Russo stated the location of the emergency exits and discussed opportunities for public comment.

A proclamation and plaque were presented to Officer Christopher Ricciotti for more than 32 years of service to the Borough of Longport. The Longport Police Department also made a presentation to Officer Ricciotti.

Likie Nika of Ozzie's Luncheonette and Joseph Tucker of Catch appeared before the Board of Commissioners regarding an application for the installation of an outdoor tent in front of their restaurants. Ms. Nika presented the Mayor with a petition to allow the outdoor tent. Solicitor Affanato explained that outdoor dining is currently permitted. He added that the Governing Body needed to decide if it would permit the covering of Borough property, the sidewalk, located in front of the restaurants. Ms. Nika and Mr. Tucker discussed their ideas and plans for a tent. There was further discussion on this topic including the safety of diners and pedestrians. The Board of Commissioners concluded that a resolution would be added to the regular meeting agenda to allow for the covering of the sidewalk. Solicitor Affanato explained that the covering/tent location, design, and pedestrian walkway would require approval by the Zoning Officer, Police Chief and Fire Chief. Commissioner Lawler noted that he would like to see a more permanent solution for the following summer season. Commissioner Lawler also discussed some future changes, including the installation of safety bollards in front of the parking spaces in this area.

Commissioner Lawler requested that Fire Chief Clayton discuss a topic that he had brought up at the last meeting as he was unable to attend that meeting. Fire Chief Clayton explained that he attended the previous meeting to request that that Governing Body reconsider allowing dogs on the beach during the summer season during from approximately 6:30 am to 8:30 am. There was further discussion on this topic. Solicitor Affanato said that he would draft an amending ordinance for the Governing Body's review.

Administrator Porter:

Administrator Porter had no further report for the workshop meeting.

Borough Solicitor Affanato:

Solicitor Affanato discussed a request by the New Jersey Division of Taxation to use the old boat dock previously used by the Longport Volunteer Fire Department. He explained that the Division could not provide a hold harmless form, but did name the Borough of Longport as 'additional insured.' He did not see any legal issues with allowing use of the dock. The Governing Body agreed to allow the NJ Division of Taxation to use the dock located behind Borough Hall.

Solicitor Affanato also discussed an ordinance drafted by the Longport Planning and Zoning Board for consideration by the Board of Commissioners at the June 1st meeting. He noted that a representative from the planning and zoning board would attend a workshop meeting to discuss the ordinance.

Borough Engineer Dennis:

Borough Engineer Dennis provided an update on the Well House #4 project. He noted that the slabs would be poured soon. He explained that work would continue through the middle of June in order to complete masonry work. He said that heavy duty work would be stopped for the summer season to minimize any disturbance in the neighborhood. He said that the permit work for the bulkhead repair at Amherst Avenue was underway. He also said he is working on 2023 State grant applications with the Public Works Department.

Bob English of 130 N. 32nd Avenue had several questions, including if the bond was increased to include the purchase of a new fire truck for the Longport Volunteer Fire Department, how payment works and how much would taxes increase. He also discussed the Longport Volunteer Fire department and supported the purchase of a new truck. He noted some of the items included in the bond ordinance are the repair of tennis courts and new playground equipment, although he said he believed that public safety should be the number one priority.

Mary Nugent of 2604 Oberon Avenue questioned what was included as 'other various capital improvements' in the bond ordinance. Administrator Porter addressed her question. Ms. Nugent also

discussed over bonding and retiring residual funds. Engineer Dennis explained that any remaining funds would be reallocated to the capital fund.

Engineer Dennis noted that he is working with the adjacent property owner, Mr. Lamberti, to repair the bulkhead. Ms. Nugent had several questions regarding the use of Borough-owned property, the sidewalk, for outdoor dining and if the restaurants provided the Borough with proper insurance, etc. Solicitor Affanato addressed her question. She also expressed concern with allowing dogs on the beach during the summer season. She said that when cleaning up after dogs that everything is not removed and was concerned about children on the beach. She felt the Governing Body should reconsider based on this premise. Ms. Nugent also requested live video streaming of Borough Commission Meetings without public participation. Solicitor Affanato noted that the Borough does currently provide live audio streaming of the meetings.
