BOROUGH OF LONGPORT WORKSHOP COMMISSION MEETING MUNICIPAL BUILDING, 2305 ATLANTIC AVE LONGPORT, NJ 08403 WEDNESDAY, June 15, 2022 – 4:00 PM

The meeting was called to order at 4:00 pm.

Municipal Clerk Kyle read the Opening Statement pursuant to the Open Public Meetings Act. A notice of this meeting was emailed to the Press of Atlantic City and The Current on June 10, 2022. In addition, copies of notices were posted on the bulletin board and filed in the office of the municipal clerk. Notices on the bulletin board have remained continuously posted.

Borough Solicitor Affanato, Administrator Porter, Engineer Dennis, CFO Kelly, Police Chief Culmone, Zoning Officer Funk, and Municipal Clerk Kyle also present.

Mayor Russo stated the location of the emergency exits and discussed opportunities for public comment.

The Governing Body presented the 2022 Beach Tag Design Contest Winners with awards. This year's winners were Luna Catanese – Regular Seasonal Badge and Ella Clark – Senior Seasonal Badge.

Administrator Porter:

Administrator Porter discussed the shared municipal court agreement with the City of Margate. He noted that there is a resolution on the regular meeting agenda to give notice to Margate of the Borough's intent to dissolve this shared services agreement.

Administrator Porter also discussed lifeguard staffing and explained that Borough had lost 18 lifeguards from last season. He noted that there might be times when some beaches would need to be closed based on staffing or the need to pay overtime.

Solicitor Affanato noted that the Borough legally was not required to pass a resolution to notify Margate of its intention to dissolve the shared municipal court agreement. He also explained that the resolution does not prohibit the Borough from continuing negotiations with Margate.

Borough Solicitor Affanato:

Solicitor Affanato discussed an ordinance he prepared that would change when beach tag preseason sale prices end. He said that the ordinance is on the regular meeting for a first reading/ introduction. If adopted, the preseason sale price would end the first Friday in June instead of the third Friday in June. He said that the ordinance would not affect this year's sales.

Solicitor Affanato also noted that the library lease with the Longport Public Library was on the regular meeting agenda for the Governing Body's consideration.

Borough Engineer Dennis:

Borough Engineer Dennis discussed resolutions on the agenda regarding three capital projects funded through recently adopted bond ordinances.

He said the Atlantic Avenue roadway project (from 22nd to 27th Avenues) would begin in the fall.

He also discussed the rehabilitation of the water tank, adding that engineering and construction on this project would also begin in the fall.

Engineer Dennis also discussed a Monmouth Avenue road project from 32nd Avenue to the Margate border. He added that this is a New Jersey Department of Transportation grant-funded project, also scheduled to begin in the fall.

He discussed a resolution on the agenda to apply for State aid for roadway improvements to Atlantic Avenue – Phase 3. He said that he would soon submit the grant application.

He also provided an update regarding construction at Well House #4. He noted that the roof is near completion and that construction would soon stop for the summer months. He explained that with the roof completed, this would allow the contractor to continue with minor work inside the building that would not be disruptive to the neighborhood. He said the last thing that the contractor would like to complete before the summer shut down is the pouring of a concrete ramp at the site. After that, heavy construction work would resume in the fall. Mayor Russo noted that the last time the Borough installed a new well was in 1964.

Mayor Russo:

Mayor Russo announced that longtime former Mayor and Commissioner William Fiore recently passed away. He said a viewing and funeral would take place on June 18, 2022. He spoke about former Mayor Fiore noting that he served honorably in the United States Army and was a member of the Longport Volunteer Fire Department for 62 years. He said that he will be missed by many.

Municipal Clerk Kyle:

Municipal Clerk Kyle noted that she had provided the Governing Body with copies of correspondence from residents regarding Ordinance 2022-09 that is scheduled to have a second reading and public hearing during the regular commission meeting. She also announced that Friday, June 17th, was the last day to purchase beach tags at preseason prices.

Approval of minutes-

Municipal Clerk Kyle requested a motion to approve the minutes from the June 1, 2022, Workshop and Regular Commission Meetings. Commissioner Lawler made a motion, seconded by Mayor Russo, to approve the minutes from the June 1, 2022, meeting. ALL AYES- none opposed. Commissioner Leeds – absent.

ORDINANCES – SECOND READING/ PUBLIC HEARING on <u>O2022-08 - An Ordinance Amending Chapter</u> 167 – Zoning, of the Borough of Longport, County of Atlantic and State of New Jersey

No one wished to speak on this ordinance.

Solicitor Affanato noted that because this is a zoning ordinance change that notice was provided to both the City of Margate and the County of Atlantic. He also noted that since the change was provided by the Longport Zoning and Planning Board that there was no need for review by the planning and zoning board as the Governing Body did not make any changes to it, and that it was OK procedurally for the Governing Body to adopt.

ORDINANCES – SECOND READING/ PUBLIC HEARING on <u>O2022-09 – An Ordinance Amending Chapter</u> <u>82-8 Dogs on Beaches</u>

Anthony Ziccardi of 1601 Atlantic Avenue, also Vice President of Costa Videre Condominiums, said that the board was against adopting this ordinance. He explained that he sent an email and letter to the

Governing Body voicing opposition to this ordinance. He expressed his concern regarding health and safety, as well as the enforcement of the new ordinance.

Vicky Magid of 1801 Beach Terrace said she was in favor of adopting the ordinance. She noted that the Borough does not have a dog park and that she and her neighbors are in favor of the ordinance that would provide a place for dogs during the summer season.

Levon Clayton of 3016 Winchester Avenue spoke in favor of adopting the ordinance. He said that there are many responsible dog owners that even clean up after irresponsible dog owners.

Bob English of 130 N. 32nd Avenue said he was in favor of giving the benefit of the doubt to dog owners. He was more concerned about unleashed dogs running on the beach and someone getting hurt. He also expressed concern regarding enforcement.

Bruce Funk of 102 S. 19th Avenue spoke in favor of the ordinance. He said that most dog owners are responsible and that there are many who clean up after dogs other than their own. He said many dog owners would self-police in order to be able to have dogs on the beaches during the summer season.

Mayor Russo expressed concern that this privilege could be abused. He also said that dogs are not permitted on tennis and basketball courts. He felt that more people were in favor of trying this out. He said if it is adopted and it does not work, the ordinance could be changed back and that he would be in favor of that doing.

Shelly Kwartler of 18 N. 35th Avenue spoke in favor of the ordinance. She noted that the only way to cool down a dog on a really hot day is either by their tongue or their paws. She said it would be beneficial for dogs to be able to put their paws in the ocean to cool down.

Suzy Lawler of 121 N. 35th Avenue spoke in favor of the ordinance. She noted that when she is on the beach that she often cleans up the beach while there and felt that others would, too.

PUBLIC COMMENT

Fran Kenny of 225 N. 36th Avenue requested an update regarding the bulkhead project on Amherst Avenue. She noted that there was no information in the minutes other than letters were sent regarding the project. Solicitor Affanato addressed her questions and concerns. He explained that Ponzio is handling the project for the Borough and that it is currently in the permitting process. He said once the permit is approved by the New Jersey Department of Environmental Protection, the Borough can then go out for bids. He added that Mr. Lamberti appears to be moving forward towards making repairs on his section of the bulkhead. Administrator Porter explained that the permitting process takes approximately 90 days.

Bob English of 130 N. 32nd Avenue asked if there was a firm price regarding the County Centralized Court System. Administrator Porter said that the amount was \$42,400, but added that it may go up a little, but that the increase would be minor. Mr. English expressed concern that if the Borough waited on joining the system, if it was possible that the price would increase. Solicitor Affanato address his concern and explained that the cost is based on a formula and should not change based on time.
