Borough Solicitor Affanato, Administrator Porter, Engineer Dennis, CFO Kelly, and Municipal Clerk Kyle also present.

Mayor Russo stated the location of the emergency exits and discussed opportunities for public comment.

Administrator Porter:

Administrator Porter discussed several annual appointments on the regular meeting agenda for the Governing Body's consideration. He added that there will be several additional appointments on the following meeting's agenda. He also noted that the annual municipal budget process has begun. He added that he is continuing negotiations with employee unions, but is nearing resolution. The Governing Body thanked him for his work with the unions.

Borough Solicitor Affanato:

Solicitor Affanato said he is working with the Building Department to develop a self-certification process regarding rentals and a change in the rental Code. He also said he would provide a draft ordinance regarding the Borough's rental Code to the Governing Body as well as local real estate representatives.

Solicitor Affanato reviewed a resolution on the regular meeting agenda to appoint new members to the Longport Planning and Zoning Board. There was further discussion on this topic.

Borough Engineer Dennis:

Engineer Dennis discussed several construction projects that are underway. He noted that work on Atlantic Avenue is scheduled to begin in two weeks. He explained that there was a weather delay with work on Monmouth Avenue, but that work was scheduled to begin tomorrow. Mayor Russo requested an update on the water tower renovation work. Engineer Dennis explained that the water tank had been drained and that scaffolding work for the containment system would start next week. He noted that some of the work would be temperature/weather related, but that the contractor did not foresee any issues with a completion date at the end of April. Solicitor Affanato added that there was an issue when transitioning from the tank to the well. He explained that some homeowners' pipes had broken and that the Borough would submit an insurance claim to pay for damages.

Engineer Dennis noted that the water tower would be back online prior to the summer season. He also said that work is nearing completion on Well #4. He explained that the Borough is waiting for the generator to be delivered for the well and the electrical service to be completed. He added that there is a certain process the Borough must go through with the NJ Department of Environmental Protection before the well is commissioned/operational.

Engineer Dennis said that the street opening repair project had been completed. He also noted that work will begin soon on the Winchester Avenue drainage project. He also discussed an informal notification from the NJ Department of Transportation regarding grant funding for a section of Atlantic Avenue near the Margate border.

Commissioner Lawler asked if there were many complaints regarding low water pressure or discoloration. It was noted that the transition for the most part was pretty smooth with the exception of a limited number of homes that had broken pipes.

Mayor Russo:

Mayor Russo provided an update on the 125th Anniversary Committee and two events that are in the planning phase to celebrate the Borough's 125th Anniversary.

Mayor Russo explained that the water is tested on a regular basis. Engineer Dennis explained that the water pressure is being impacted, not the source of where the water is coming from. Although, he added that Public Works has been actively working to maintain consistent water pressure. It was noted that any discoloration would dissipate after letting the water run. There was further discussion on this topic.
