The meeting was called to order at 4:00 pm.

Alternate Borough Solicitor Agnellini, Administrator Porter, Chief Culmone, CFO Kelly, Engineer Dennis, Library Director Gerhardt, and Municipal Clerk Kyle also present.

Mayor Russo stated the location of the emergency exits and discussed opportunities for public comment.

# Administrator Porter:

Administrator Porter discussed the municipal budget for 2023. He noted that it would be introduced soon.

He also discussed new playground equipment for 33<sup>rd</sup> Avenue and the beach. He said the delivery date for the equipment would be July 2023. He wanted direction from the Governing Body on how it wanted to handle installation of the equipment. Mayor Russo suggested waiting for installation after the summer season. Administrator Porter explained that there is a delay in the delivery of the equipment. He added that the Borough was clear that it wanted the equipment installed before the summer season. There was discussion on possibly delaying delivery of the order. One of the concerns is if it is delivered in July there is no space to store the equipment until it is ready for installation. There was further discussion on this topic.

Administrator Porter also requested that the Governing Body withdraw Resolution 2023-39 as some additional details needed to be addressed prior to adoption.

#### Alternate Borough Solicitor Agnellini:

Alternate Borough Solicitor Agnellini had nothing to report.

#### **Borough Engineer Dennis:**

Engineer Dennis discussed ongoing construction projects in the Borough and provided updates on the following: Atlantic Avenue roadway construction, the Monmouth Avenue roadway project, and the water tower renovation project. He added that there have been weather delays regarding the water tower project, but that the interior and exterior have been blasted and are ready to be painted. He also discussed well building #4 and said that the Borough is waiting for the electric company to finish service

work. He said that the 36<sup>th</sup> Avenue bulkhead project will be starting soon and that the contractor will hang a sediment curtain as a precursor to construction. He also discussed a resolution to award the tennis and pickle ball court renovation project. He added that one tennis court would be removed and replaced with pickle ball courts. He said the work would be completed before Memorial Day. He discussed the firehouse floor resurfacing project. He also discussed upgrades of the police holding cells. He noted that he met with library representatives regarding its proposed library expansion and that his office reviewed the scope of the project.

Mayor Russo asked if the Borough had passed the stage where residents could still experience water pressure fluctuations. It was noted that it has not. Commissioner Leeds noted that there had been discussion previously regarding the pickle ball courts, including that one will be added where a tennis court used to be.

#### Mayor Russo:

Mayor Russo provided an update on the next 125<sup>th</sup> Anniversary Committee meeting, adding that the next scheduled meeting is April 4<sup>th</sup> at 4 pm. He also provided an update on the food vendors for the Town Party.
