NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Longport that the 2014 beach vending license held by Paul VandeRijn is hereby renewed and extended for the 2016 vending season, provided that the renewal and extension fee of **\$33,745.92** (includes the 4% increase) is paid to the Borough of Longport on or before April 15, 2016; and

BE IT FURTHER RESOLVED, that the issuance of the vendor license for the 2016 season is subject to the terms and conditions of the bidding documents; and

BE IT FURTHER RESOLVED, that the attached schedule of products and prices is adopted for the 2016 season and following seasons; and BE IT FURTHER RESOLVED that all resolutions inconsistent with the provisions hereof are hereby repealed, and this resolution shall be effective immediately.
