**AUTHORIZING THE RELEASE OF FUNDS  
FOR THE LONGPORT POINT REVETMENT PROJECT  
11<sup>th</sup> Avenue Terminal Groin to Atlantic Avenue Jetty**

**WHEREAS**, the New Jersey Department of Environmental Project has informed the Borough that bids were received for the above referenced Project; and

**WHEREAS**, the Longport Point Revetment Project is being funded by both a Federal FEMA Authorization for repairs to the 11<sup>th</sup> Avenue Terminal Groin and Atlantic Avenue Jetty as a result of damages from Super Storm Sandy and a State Aid Agreement for the improvements to the existing stone revetment between the 11<sup>th</sup> Avenue Terminal Groin and Atlantic Avenue Jetty as a result of the SrmY Corps of Engineers Absecon Island Shorefront Protection Project; and

**WHEREAS**, the Borough has been provided a letter dated June 08, 2017 and a copy of the Bid Tabulation dated May 02, 2017 from the Bureau of Coastal Engineering indicating the Total Amount of the award to the lowest responsible bidder as well as a breakdown of the total cost of items relating to the Federal FEMA Project and the NJDEP State Aid Agreement; and

**WHEREAS**, the Municipal Engineer and Municipal Chief Financial Officer have reviewed the letter and the bid tabulation and are in agreement with same.

**NOW, THEREFORE BE IT RESOLVED** that the Governing Body of the Borough of Longport formally directs the Municipal Chief Financial Official to release a check to the 'Treasurer, State of New Jersey' for the total amount of **\$1,521,451.39**, which amounts reflects the Municipal Share of the State Aid portion of **\$520,236.20** and the refundable Federal FEMA portion of **\$1,001,215.19**; and

**BE IT FURTHER RESOLVED** that a Certificate of Availability of Funds issued by the Municipal Chief Financial Officer is attached hereto.
