**AWARD OF CONTRACT TO
CP ELECTRIC OF ABSECON, N.J.
FOR THE INSTALLATION OF LED LIGHTS AT
THE FIREHOUSE-2nd Floor**

WHEREAS, two (2) informal quotes were received by the Fire Chief from CP Electric and Buck's Electric; and

WHEREAS, upon review of said responses by the Municipal Chief Finance Officer/Purchasing Agent and Fire Chief, it was determined that **CP Electric** provided the most responsible proposal, price and other factors being considered; and

WHEREAS, the Municipal Chief Finance Officer/Purchasing Agent and Fire Chief are recommending award a Contract to **CP Electric** of Absecon, N.J. for the Total Amount of **\$5,910.00** as stated in their Proposal dated October 11, 2019.

NOW, THEREFORE, BE IT RESOLVED by the Longport Borough Board of Commissioners that the aforementioned recommendation is hereby accepted and that said Governing Body hereby awards a Contract to the apparent lowest responsible responder, price and other factors being considered, **CP Electric** of Absecon, N.J. for the **Installation of LED Lights** at the Firehouse-2nd Floor, for the Total Amount of **\$5,910.00** as stated in their Proposal dated October 11, 2019; and

BE IT FURTHER RESOLVED, that the Municipal Chief Finance Officer is hereby directed to issue the required Purchase Order to **CP Electric**; and the Fire Chief are hereby directed to authorize the Contractor to proceed with said work, all in accordance with their Proposal dated October 11, 2019; and

BE IT FURTHER RESOLVED that a Certificate of Available Funds has been issued by the Chief Financial Official and is attached to this Resolution as required by Law.
