**AWARD OF CONTRACT FOR A STATE AID PROJECT  
TO ARAWAK PAVING COMPANY OF HAMMONTON, N.J.  
FOR THE MA2019 IMPROVEMENTS TO ATLANTIC AVENUE  
From 32<sup>nd</sup> Avenue to Margate City Line**

**WHEREAS**, the Municipal Purchasing Agent and Municipal Engineer, on the publicly advertised date and time of September 22, 2020 at 2:00 PM, opened three (3) Bid Proposals for the **MA 2019 IMPROVEMENTS TO ATLANTIC AVENUE - From 32<sup>nd</sup> Avenue to Margate City Line** as indicated on the attached Bid Tabulation; and

**WHEREAS**, the Municipal Engineer has reviewed the Bid Proposals; determined that the lowest apparent bid is within budget; and has recommended award to the apparent lowest responsible bidder, price and other factors being considered, **Arawak Paving Company** of Hammonton, New Jersey, for their **Total Amount Bid** of **\$195,900.00**.

**NOW, THEREFORE, BE IT RESOLVED** by the Longport Borough Board of Commissioners that the recommendation of the Municipal Engineer is hereby accepted and that said Governing Body hereby awards, subject to approval of the New Jersey Department of Transportation, a Contract to **Arawak Paving Company** of Hammonton, N.J. in an amount of **\$195,900.00** for the **MA2019 Improvements to Atlantic Avenue-From 32<sup>nd</sup> Avenue to Margate City Line**, and

**BE IT FURTHER RESOLVED**, that the Longport Borough Board of Commissioners recommends to the New Jersey Department of Transportation that the contract for the **MA2019 Improvements to Atlantic Avenue - From 32<sup>nd</sup> Avenue to Margate City Line** in the Borough of Longport, County of Atlantic be awarded to **Arawak Paving Company** of Hammonton, N.J. whose **Total Amount Bid** is **\$195,900.00**; and

**BE IT FURTHER RESOLVED**, that the Mayor be and is hereby directed to sign, and the Municipal Clerk directed to attest to with the Corporate Seal, the contract in the prescribed form for said construction; and

**BE IT FURTHER RESOLVED** that a Certificate of Available Funds has been issued by the Chief Financial Official and is attached to this Resolution as required by Law.
