## AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH A.W. PONZIO AND ASSOCIATES OF ATLANTIC CITY, N.J. FOR PERMITTING RELATING TO THE FIRE BOAT LIFT AT THE MUNICIPAL RECREATION COMPLEX 2305 Atlantic Avenue at Bay

**WHEREAS**, the Borough of Longport has allocated Capital Improvement Funding for the installation of a Fire Boat Lift at the rear of Municipal Hall along Risley's Channel; and

**WHEREAS**, the Governing Body of the Borough of Longport previously awarded a Non Fair and Open Professional Services Contract to **A. W. Ponzio and Associates** per Resolution 2020-39 for permitting relating to the fire boat lift at the municipal recreation complex at 2305 Atlantic Avenue at the bay in the amount not to exceed \$ 4,400.00 pursuant to the provisions of NJSA 19:44A-20.5:

**WHEREAS**, during the course of the permitting process, A.W. Ponzio and Associates of Atlantic City incurred additional expenses of Certified Mailings and Atlantic County Clerk-Permit Recording Fee resulting in additional costs of; and

**WHEREAS**, the Professional Service Fee requested in additional costs is \$ 291.00, bringing the Total Professional Fee Service Not to Exceed \$ 4,691.00; and

WHEREAS, the anticipated term of said Services is not for more than one year; and

WHEREAS, A.W. Ponzio and Associates has previously completed and submitted a Business Entity Disclosure Certification which certifies that A.W. Ponzio and Associates has not made any reportable contributions to a political or candidate committee in the Borough of Longport within the previous one year and, further, that this Contract will prohibit A.W. Ponzio and Associates from making any reportable contributions through the term of this Contract; and

**WHEREAS**, The Municipal Administrator has reviewed the extra fee requested and has recommended for its acceptance; and

**WHEREAS**, a Certificate of Availability of Funds has been issued by the Municipal Chief Financial Officer and is attached to this Resolution.

**NOW, THEREFORE BE IT RESOLVED** by the Governing Body of the Borough of Longport that it hereby accepts the additional costs dated February 1, 2021 with **A.W. Ponzio and Associates** for a Not to Exceed amount of **\$4,691.00** and hereby directs the CFO to make payment to **A.W. Ponzio and Associates** for the extra costs consistent with Proposal dated February 20, 2020; and

**BE IT FURTHER RESOLVED** that a Notice of this Contract Award shall be published at least once in the Atlantic City Press pursuant to the requirements of Chapter 198 of the New Jersey Laws of 1971.
