BOROUGH OF LONGPORT WORKSHOP COMMISSION MEETING MUNICIPAL BUILDING, 2305 ATLANTIC AVE LONGPORT, NJ 08403 WEDNESDAY, APRIL 17, 2024 – 4:00 PM

The meeting was called to order at 4:01 pm.

Municipal Clerk Kyle read the Opening Statement pursuant to the Open Public Meetings Act. A notice of this meeting was emailed to the Press of Atlantic City, The Ocean City Sentinel, the Star Ledger, and Courier Post on April 12, 2024. In addition, copies of notices were posted on the bulletin board and filed in the office of the municipal clerk. Notices on the bulletin board have remained continuously posted.

Alternate Borough Solicitor Agnellini, Administrator Porter, CFO Kelly, Engineer Dennis, Municipal Auditor Garcia, Sgt. Burgan, Library Director Gerhardt, and Municipal Clerk Kyle also present.

Mayor Russo stated the location of the emergency exits and discussed opportunities for public comment.

Presentation:

Mr. Gunn Lee, retired Longport United States Postal Office mail carrier, donated a drawing he made of the former Longport Post Office on 27th Avenue to the Borough of Longport for display in the historical society museum. The award-winning drawing was also featured in a calendar for the USPS and went on a tour of the US. Jeff Fusco, also a retired Longport USPS mail carrier, presented a brick from the recently demolished post office. Greg Kilar, current Longport USPS mail carrier and President of Branch 370 National Association of Letter Carriers presented a set of keys to the former post office. The three were thanked for their generous donations to the Borough of Longport.

Library Director Gerhardt discussed a needed repair to the Historical Society Museum building's balcony above the porch. He said water is seeping through the balcony area and that it must be repaired. He noted that the library has asked Borough Engineer Dennis to work on the project. He added that the library has budgeted \$125,000 for the repair and that because the building is on the historic registry that repairs must be done according to certain guidelines. He anticipated that work would begin in the fall.

Administrator Porter:

Administrator Porter discussed the new playground equipment at 33rd and Atlantic avenues. He noted that he hoped the playground would be finished and opened to the public by the following Thursday. He said that current work includes the pouring of a rubber surface. Engineer Dennis explained that the rubber surfacing being poured at the playground is the same material used at playgrounds throughout the State.

Administrator Porter also discussed the balcony repair project at the Historical Society Museum and noted that Bureau of Ocean Energy Management (BOEM) as part of its studies regading the offshore wind farm project, has set aside funding for the historic Coast Guard Building due to noted visual impairments from the future offshore windfarm. He noted that the BOEM has allocated \$55,000 for use

at the building. He noted that the Borough should get confirmation regarding funding in July. He also added that he met with the Recreation Supervisor and that a new online reservation system is being set up for the tennis and pickleball courts for use this summer.

Alternate Borough Solicitor Agnellini:

Alternate Borough Solicitor Agnellini – no reports.

Borough Engineer Dennis:

Borough Engineer Dennis noted that the Administrator had provided an update on the playground. He added that he sent out quote requests to re-stripe angled parking spaces on Atlantic Avenue. The project is anticipated to be completed before Memorial Day.

Mayor Russo requested that Municipal Clerk Kyle make several announcements.

Engineer Dennis will reach out to the County regarding the traffic light at 29th Avenue. Administrator Porter also noted that he received a copy of the complaint and had reached out to NJ Transit.

Commissioner Leeds also discussed a complaint received during the beach sweep. There was discussion about sand covering items including benches. Commissioner Lawler noted that the public works department will soon begin cleaning the beaches to have them ready in time for the start of the summer season.

He discussed some of the items that increased municipal spending, including salaries and wages, insurance, pension costs, and capital costs.
